DATABASE CHANGES Explanatory Notes

This section of the documentation describes the way in the 1997-98 database has changed in relation to the 1996-97 database. Changes are described in terms of the names of the affected variables and codes. This section of the User Documentation is in 11 parts.

Parts 1-3 - Changes to raw variables

Changes to raw variables are listed in terms of those that are new for 1997-98, those that have been deleted from 1996-97 and those which have been amended from 1996-97, including a description of the change.

Parts 4-6 - Changes to derived variables

Many derived variables remain unchanged in name, but it should be remembered that there may well be changes in the contents of the variables that feed into them. You should check the compositions of the variables you intend using. Changes to derived variables are listed in terms of those that are new for 1997-98, those that have been deleted from 1996-97, and those which have been amended from 1996-97, including a description of the change.

Parts 7-9 - FES expenditure codes

Expenditure codes are listed and explained in Section 4 of the User Documentation. Part 7 details expenditure codes which are new to 1997-98, Part 8 details expenditure codes which have been deleted from 1996-97 and Part 9 shows expenditure codes which have amended from 1996-97 - details of the changes are given.

Parts 10-11 - Changes to tables

Part 10 details new tables which have been set up for 1997-98 and describes their contents. Part 11 details tables that have been deleted from 1996-97.

MAJOR CHANGES

1995-96 to 1996-97 Changes

Self-employment - The way in which information about income from self-employment is collected was substantially revised in 1996-97 following various tests and pilot studies. The quality of such data will be increased but this may lead to a discontinuity. See Section 5, Part 13 - Questionnaire Changes for full details.

Cable/satellite television - Information on cable and satellite subscriptions is now collected from the household questionnaire rather than from the diary, leading to more respondents reporting this expenditure.

Mobile phones - Expenditure on mobile phones was previously collected through the diary. From 1996/97 this has been included in the questionnaire.

Job seekers allowance (JSA) - Introduced in October 1996 as a replacement for Unemployment Benefit and any Income Support associated with the payment of Unemployment Benefit. Receipt of JSA is collected with NI Unemployment Benefit and with Income Support. In both cases the number of weeks a respondent has been in receipt of these benefits is taken as the number of weeks receiving JSA in the last 12 months and before that period the number of weeks receiving Unemployment Benefit/Income Support.

Retrospective recall - The period over which information is requested has been extended from 3 to 12 months for vehicle purchase and sale. Information on the purchase of car and motorcycle spare parts is no longer collected by retrospective recall, instead expenditure on these items is collected through the diary.

State benefits - The lists of benefits specifically asked about were reviewed in 1996/97. See the Income Questionnaire for more information.

Sample stratifiers - New stratifiers were used in 1996/97 based on standard regions, socio-economic group and car ownership.

Government Office Regions - Regional analyses are now presented using the Government Office Regions (GORs) formed in 1994. Previously all regional analyses used Standard Statistical Regions (SSRs).

Full questionnaire changes - please refer to Section 5, Part 13 for full details.

Checking for changes

The checking of variables can be done using the different parts of this Section of the documentation. Particular points to check are:

Has the specification of the variable changed?

The formula from which a variable is calculated may have changed or the conditions on which that formula is based may have changed. Specification changes can be confirmed using other parts of this section of the Documentation, particularly Parts 3 and 6. The structure of the 1996-97 product codes is given in more detail in Section 3, Part 4 of the Documentation. Details of the specification of individual variables are available on request.

Has the coding frame changed?

Changes to coding frames can significantly alter the distribution of data within a variable or a group of variables. It is very important that coding frame changes are noted. Changes to coding frames for raw variables can be confirmed using Parts 3 and 6, or Part 13 which shows coding changes in the context of the questionnaires.

Has the question wording changed?

This can be confirmed using Part 13.

QUESTIONNAIRE CHANGES FROM APRIL 1996 Based on a paper by Social Survey Division

This paper lists the changes in the content of the FES questionnaires from April 1997. It covers new questions, deletions, amendments to wording, coding changes within specific questions on the Household and Income questionnaires and major routing changes.

The first column gives the question reference number used in the 1997-98 questionnaire and the second column gives the question reference number used in the 1996-97 questionnaire. If this number is pre-fixed by 'H' then the question can be found in the Household Questionnaire and if it is pre-fixed T' it can be found in the Income Questionnaire.

The third column gives the 1997-98 question text and explains the nature of the change: in the case of completely new questions a routing statement is included, e.g. APPLIES IF BUYING WITH MORTGAGE, followed by the question text. Changes to coding or wording are indicated by "CODING CHANGE" or "REWORDED" followed by the new codes or wording.

Questions are covered by topic area, e.g. mortgages.

The full text and routing for all questions and the diary coding frame are available in separate documentation, see Section 6 - Variable Relationships.

Changes to the questionnaire in 1997-98

The main changes to the FES questionnaire for 1997-98 are summarised below. Most of the changes were made as a result either of the desire to harmonise questions asked on Government surveys.

- 1. Information on household composition (for harmonisation)
 - a. New question on date of birth of those aged under 20.
 - b. Separate questions on *de facto* and *de jure* marital status.

 - d. Separate code for cohabitee in the relationship grid.
 - e. Introduction of a question on ethnic group (for each person).
