Title: The Sheffield Club Membership Book (18/03/1873-20/05/1970)

Types of information: record number, name of candidate, profession of candidate, residence of candidate, name of proposer and seconder, whether candidate was elected and/or comment.

Strengths and weaknesses: Strengths – virtually complete transposition from manuscript source; Weaknesses – In a few cases the handwriting could not be read

Time period: 18/03/1873-20/05/1970

Periodicity of the data: Determined by the election cycle of the Sheffield Club

Name of the country, region, county, town or village covered: Sheffield, Yorkshire, England

Types of spatial units: Individual

Provenance

i) Who created the data collection and why?

Dr Alan White and Catherine Arthur, both of the Department of Sociology and Anthropology, University of East London, created the data. Catherine Arthur was the research assistant for this project and input most of the data. Her time to do this was funded by the Department of Sociology and Anthropology, University of East London.

Dr White discovered the manuscript copy of the membership book in 1982 whilst exploring the archives of the Sheffield Club. The membership book is now in the archive section the Sheffield City Library.

The data was created in spreadsheet form to allow export into the Ucinet5 package for analysis of network patterns.

ii) Which sources were used to create the data collection?

The data was taken in main from the manuscript copy of the Membership Book for the Sheffield Club, 1873-1970. Dr Alan White discovered this amongst the archives of the Sheffield Club, which were then (1982) located at the Club House in Surrey Street, Sheffield. The archives are now deposited with Sheffield City Library. In a few cases it was necessary to refer to contemporary Sheffield Commercial directories due to indecipherable, or faded, writing.

All data was transcribed from the original apart from the residence address of the candidate.

The data is in reverse data order to that given in the manuscript book (that is, date of vote for membership).

ii) Structure

There is one file (Sheffield Club membership book.xls/.tab). There are 1,673 records. Each record has seven fields. Each record represents a line of the manuscript source. The first field in each record is a unique identifying number. This is not present in the original.

The fields, and their characteristics, are as follows:

No. – Unique case number. Numeric data. Four digits.

Date – Date of election in British format: DD/MM/YYYY. Numeric data.

Name - Name of nominee given in last name, first name format. Initials have been left as in the original source. Alphabetical data.

Profession – The profession of each nominee as shown in the original source. Alphabetical data.

Proposed by - Name of proposer given in last name, first name format. Initials have been left as in the original source. Alphabetical data.

Seconded by - Name of seconder given in last name, first name format. Initials have been left as in the original source. Alphabetical data.

Remarks – In the manuscript this column shows if a candidate was successful in the vote for membership; if they withdrew their application for membership before a vote; or, in a very few cases, contains a comment. If the candidate was voted in as a member this field has been left blank. In all other instances the contents of the column have been transcribed as in the original.

In all other cases a blank field indicates a blank column in the original source.

A pair of ?? around a name or occupation indicate that the handwriting in the original source could not be deciphered. A single ? indicates that one or more characters from the original source could not be deciphered.
