A few words of Introduction

The Family Resources Survey collects information on the incomes and circumstances of private households in the United Kingdom (or Great Britain before 2002-03).

The survey is sponsored by the Department for Work and Pensions. Whilst it was designed with our needs specifically in mind, it contains information that will be of interest to researchers and analysts from a wide range of disciplines in both the public and private sectors.

The survey includes household characteristics; income and receipt of Social Security benefits; tenure and housing costs; assets and savings; carers and those needing care; and employment.

This 'Introduction to the FRS' is aimed at providing a background to how the data is collected and then information on using the dataset that is derived from the survey. Further information on the survey can be found in our annual report.

The FRS Database

There are two versions of the FRS dataset; a fully edited version called Release 1 and an unedited version called Release 0. These are both available in either Hierarchical or Flatfile format and are stored on both London Unix boxes.

When data for a FRS year is updated, or amended, a new release is created for users. The old release is not deleted, so can still be accessed if required.

To avoid problems in accessing the data users are given two choices, to either use the Latest data available or select the required dataset release.

Weeklyisation

Virtually all amounts on the FRS are weeklyised – ie the figure given is pounds per week. The original period codes are provided so you can get back to the original answer if you wish. For example `payamt=340.02279452`, `paypd=5` suggests the respondent gave a figure of 1477:50 per month. The exceptions are lump sums, which have a period code of 95, and certain figures where we ask for all payments over a certain time period (for example all bonus payments in the last 12 months) which do not have associated period codes.

'LATEST' directories

The virtual 'Latest' directories listed below provide links to the latest official edited releases for each survey year. They are automatically re-linked to any new data as soon as it is released. Using these directories in your libname statements, you can guarantee always to be using the latest official release, without having to update your libname statements.

The FRS data exists in both in a series of hierarchical tables and also in the form of a flatfile. A description of both structures is given below.

The Hierarchical dataset

Background

The FRS database consists of about 24 (depending on year) hierarchical, normalised tables, each table relating to a particular level (e.g. household, benefit unit) or type of information (e.g. pensions). Three main versions exist: the first covering edited and imputed fully co-operating households (the main database used by analysts); the second covering unedited data, as received from the survey contractors; and the third covering partially co-operating households (held for reference). Other data sets with different structures exist for non-responding households and other types of information relating to the data, e.g. a transactions data set of edits applied.

General-purpose tables covering household, benefit unit, adult and child information will contain a record for each household, benefit unit, adult and child in the sample. Other more specialised tables will contain records on the basis of the relevant routing of the questionnaire/circumstances of respondents. For example, the owner table will only contain records for those households who are owner-occupiers. Similarly, the benefits table will only contain records for benefits that are received by respondents. Individual records are uniquely identified by a combination of one or more key variables.

The household table (and, from 2000-01, benunit and adult tables too) also hold the variable 'gross', which is a weight variable. This serves two purposes: firstly to scale figures to the total population and secondly to compensate for non-response to the survey. It is advisable

to use grossed data for all analyses to reduce the amount of bias introduced by non-response.

Key variables

The highest level in the hierarchy is the household level. Records in this table (*househol*) are identified by the key variable *sernum* (serial number). Serial number is made up of a combination of the area, address and household codes, plus an additional figure to denote the year. Each household may consist of a number of benefit units, records for which are identified by the additional key variable *benunit*. Each benefit unit (and household) will consist of a number of adults and/or children, whose records are each identified by a unique *person* number as the third key. (Note *sernum* and *person* are enough to uniquely identify individuals in the sample.)

Below these main levels, other key variables exist depending on the table of interest. For example, an individual may receive a number of State and non-State benefits. Information about each benefit is held in a separate record in the *benefits* table. The key variables *sernum*, *benunit*, *person*, plus the additional key, benefit, uniquely identify each record.

Similarly, a household that is buying its house with one or more mortgages may have one or more endowment policy/PEP/Unit Trust investments covering each loan. Information on these policies is held in the *endowmnt* table. Each record is referenced by *sernum*, *mortseq* (mortgage sequence number) and *endowseq* (policy sequence number relating to that mortgage).

Key variables of the same name have the same coding frame across the database and can be used to relate information from different tables. For example, to look at the type of direct payments made by respondents alongside the total amount that is paid, the tables *benefits* and *dsspay* would be related by the keys *sernum*, *benunit*, *person*, *benefit*. Similarly, to look at the age of recipients of benefits, the *benefits* and *adult* tables would be related using *sernum*, *benunit*, *person*. Or to look at contributions made by someone outside the household to mortgages, the tables *mortgage* and *mortcont* would be related by *sernum*, *mortseq*.

Normalisation principle

As far as possible, the database is normalised, i.e. duplication is eliminated and redundancy (number of skipped – not asked - values in any given table) is kept to a minimum. This requirement influences where variables are held (although some level of redundancy is accepted to draw together information relating to a single topic). For example, although the question *anymon* (whether any money left in current account at the end of each month) relates to assets, it is held on the *adult* rather than *assets* table. This is because *anymon* relates to only one of 20 different asset types and is only asked once of each adult. If held as a separate variable on the *assets* table in the majority of records it would have a skipped value, and this would be wasteful. In the *benefits* table this type of requirement is met mainly by the use of multi-purpose variables (*var1-var3*), which are used to hold responses to a variety of different questions asked of different benefits.

Table Descriptions

The table below gives an overview of the information held in each of the tables of the FRS data set, together with key variables used to identify individual records. For a more detailed description including variable names, please refer to the full year-specific documentation.

accounts	SERNUM, BENUNIT, PERSON, ACCOUNT <i>(account type, held by each person)</i>	Income from interest/dividend bearing assets and savings together with (for a subset of records) the value of National Savings products for the accounts/investments held by adults. Each record relates to a type of investment (current account, savings account etc). Adults may have more than one type of investment, each record giving the total interest/dividends received (if they have more than one account of that type). For National Savings products, if the adult is not routed into the assets questions, a banded figure for the value of the investment is collected (those entering the assets block will have an accounts record but with this variable skipped).
admin	SERNUM	Household level fieldwork admin data, e.g. final outcome codes. Each record relates to a household in the sample.
adult	SERNUM, BENUNIT, PERSON	Responses to various questions asked of adults. Each record relates to an adult in the sample (complete coverage of all adults).
assets	SERNUM, BENUNIT, PERSON, ASSETYPE <i>(asset type),</i> SEQ <i>(sequence number for that group of assets)</i>	Value and other information about assets and savings held by adults. Unlike the accounts table, each record relates to an individual investment (savings account, ISA, PEP, shares with a single company etc), except for certain National Savings Products where the total value of specific types (e.g. income bonds, capital/deposit bonds) are recorded together. Adults may hold more than one investment of the same type. Data are collected for the subset of adults routed into the assets block of the FRS questionnaire. Assetype has the same coding frame as account on the accounts table. Seq is the sequence number through one or a group of assets, as determined by the block of the questionnaire, e.g., one block covers, NSB ordinary and investment accounts, TESSAs, Gilts, and other types of saving. Please refer to more detailed documentation for the maximum number of records per asset type.
benefits	SERNUM, BENUNIT, PERSON, BENEFIT <i>(benefit type, held by each person)</i>	Amount and other information on State and non State benefits received by adults in the sample. Also includes information on the total amount of direct payments as part of IS/JSA, as well as information on Social Fund loans held and future receipt of some benefits. Each record relates to an individual benefit. An adult may receive more than one benefit but not more than one of the same type.
benunit	SERNUM, BENUNIT	Benefit unit level data. Each record relates to a benefit unit in the sample (complete coverage of all benefit units). Up to 7 benefit units.
care	SERNUM, BENUNIT, NEEDPER <i>(person receiving the care)</i>	Information on those needing care. Each record relates to an individual in the household or various categories of individual outside the household (e.g. parent or child outside the household/client of a voluntary organisation). Needper is therefore

Each record relates to a type of deduction. Benefit type is either IS or JSA direct payments, using the same keys as in the benefits table. All variables in this table are key variables. Househol	SERNUM	Information collected at the household level. Each record relates to a household (complete coverage of all households).
Insuranc	SERNUM, INSSEQ <i>(sequence number of insurance policy within household)</i>	Information on insurance policies held by household members. Each record relates to an individual policy. Binary variables POLINS1-14 identify household members covered by each policy (e.g. POLINS1=1 means person 1 is covered). A household may have more than one insurance policy (to a maximum of 6).

The full set of questions are asked separately for each purchase loan (to a maximum of 2). Mortseq does not necessarily take consecutive values: 1 and 2 relate to house purchase and will be consecutive, i.e. no household has mortseq=2 without mortseq=1. However, mortseq=3 relates to loans for essential repairs (including for those who own their property outright). A household may have mortseq=3 only, or mortseq=1 and mortseq=3. Information on vehicles owned or in continuous use by household members. Each record relates to a vehicle. Each household may have more than one vehicle (to a maximum of 8).

The Flatfile

Whereas data for the same benefit unit is split into numerous tables in the hierarchical dataset, the flatfile contains rows for each benefit unit in the years' dataset. The following example shows how the data for a particular household is held in both formats:

On the hierarchical dataset, the data for this household is linked by a serial number on the HOUSEHOL table. For example, in this case of a household made up of a family of four; one benefit unit with information at this level is stored on the BENUNIT table. Information about the husband and wife is then stored on the ADULT table, with a separate record for each person. Similarly, information on the two children is held on the CHILD table (one record for each child).

The flatfile would take all this information about this benefit unit (all four family members) and store it on one single line starting with household variables, then benefit unit variables, head of household variables, spouse variables, child 1 variables, and so on.

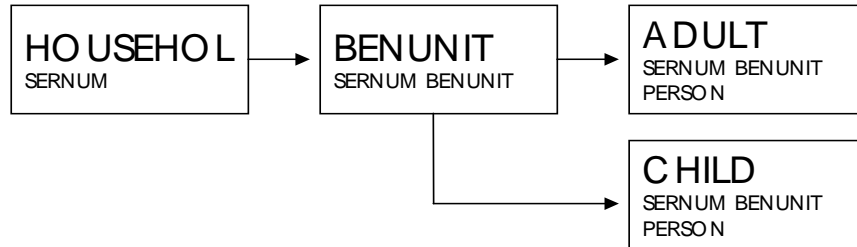

Variables have different names on either dataset, despite holding identical information. Variables from the hierarchical datasets are mapped to the flatfile using suffixes to distinguish the person to whom the variable relates where necessary. Continuing the example from above:

Introduction

The two most useful documents are the *Questionnaire Instructions* (in Word) and *Hierarchical Documentation* (in Excel, under 'Metadata'). Both are year specific. *Questionnaire Instructions* has the exact question asked for every variable, together with interviewer guidance, and sometimes an indication of who is asked the question and some of the checks carried out *Hierarchical Documentation* holds every variable with its label, possible values, and technical info.

Hierarchical Documentation also includes information on derived variables, which we create and which therefore won't be in the questionnaire instructions.

The FRS publication gives background information and some methodological details.

For flatfile users, *Flatfile Mapping* may have to be used to link flatfile variables to the appropriate hierarchical variables.

Where do I start?

The 'general', ie non-year specific, guidance is suitable for new users. *Introduction to the FRS* is a basic guide to using the survey. *Analysing the FRS* gives advice on how to analyse the datasets and weight data, with some example SAS programs. The FRS publication introduction and methodology give an overview of how the survey works.

What does the FRS have on...?

The best place to start is probably *Questionnaire Instructions*.

If you are interested in a broad area (pension income) then start with the list of question blocks. There are two lists, one at the start which covers questions asked once for each household and one half way through (exact page reference given after the first block) for questions asked to each benefit unit/adult.

If you are interested in something more specific (health insurance policies) then you can try and identify the relevant blocks, or you can do a word search on the name. Be careful – a search for insurance policy will fail if the questionnaire talks about insurance policies. Try

'insurance' or 'insurance pol'. If you are getting a lot of matches, try *Hierarchical Documentation*. Again do a search on relevant words. This document only has the short labels for each variable so there are fewer words to look through, but things may not be labelled as you expect. For example if you wanted Educational Maintenance Allowance, neither of the three words would find the match as the label refers to EMA.

I've found the question, now which variable is that?

Generally the variable will follow the question name. Where more than one answer may be correct it may feed into separate variables, which will be the question name with a suffix. For example, the question Emppay "Do you contribute to any of these pension schemes" shows three types of pension scheme, and a fourth option of 'none'. The answer to scheme type1 goes into variable emppay1, the answer to type 2 goes into emppay2 and 3 into emppay3. More than one of the three variables may have a positive answer.

If you can't find it, *Hierarchical Documentation* gives the question name for each variable. It also gives the table the variable will be found on. Be careful, some variables may be on two tables (eg age on adult and child).

Flatfile Mapping will take you from the hierarchical name to the flatfile name.

What does this variable mean?

Two options, depending on whether it is a derived variable or not.

In either case, *Hierarchical Documentation* has every variable with its label beside it. It will also have an indicator for whether or not it is a derived variable, and if not derived it will give the question it comes from.

If it is not derived *Questionnaire Instructions* gives the exact question asked, with some details and guidance. There is an index of question names at the end. Sometimes a question will lead to several variables with different suffixes, eg the question emppay matches variables emppay1, emppay2, emppay3, so if doing a search knock off any trailing digits.

There are also multi-purpose variables Var1, Var2,... on the benefits table, which hold different information for different benefits. Look at *Benefits* for further information.

If it is derived, the DV spec will give the exact definition and derivation. If you can't immediately identify the required spec, use *Derived Variables Metadata*.

What does this answer mean?

All the answers are held in numeric format. *Hierarchical Documentation* has the key.

Some variables hold the answers 1 for yes, 2 for no and 3 for none. These are set-type variables. They come in groups (emppay1 emppay2 emppay3) which have come from one question (emppay) which has several options (1, 2, 3) plus an option (4) for none of these. More than one of the first three can apply. So if they answer yes to at least one of 1, 2, 3 the relevant variable(s) holds 'yes' and the other(s) 'no'. If they say none, all three variables will hold 'none'. There is never a mixture of 'yes's and 'none's in one group of set types.

Who is asked this?

Initially, *Questionnaire Instructions* gives you some idea. If you want the exact routing *Questionnaire Routing* holds it. Unfortunately this is written in computerese, and can be hard to follow.

More generally, the methodology chapter of the publication gives details of who is eligible for the survey.

How reliable is this?

The methodology chapter in the FRS publication includes estimates of standard errors and design factors for certain estimates. Multiply the two to get the true standard error. It also holds details of the imputation and editing we do – areas with a high level of imputation may be less robust. The assets data is a particular problem.

What about earlier years?

You can look up earlier years' information in the equivalent documentation, but the spreadsheet *Changes Metadata* gives brief details of changes made for that year.

What about earlier releases?

Releases Documentation describes the changes between different releases of the same years data.

This result looks odd, what's going on?

The FRS Users' Database holds previous queries on odd results, generally problems with one or two variables and sometimes just with a single respondent. Look here to see if one of them could be affecting you. If you still have a problem then please contact one of the FRS team.

Documentation for users who are new to the FRS

Questionnaire Instructions.doc

This gives the interviewers' instructions for the questionnaire, and is useful when trying to understand the context and routing of the questions. However, it should not be treated as definitive: instructions are updated manually and may therefore be prone to error. For documentation generated directly from the FRS interview program, see Routing documentation.

Imputation

This summarises variables with highest levels of missing responses and imputation methods used.

Hierarchical documentation

This spreadsheet describes the hierarchical data set, including documentation that relates the data set back to the FRS questionnaire:

- ◆ Column A – TABLE – The source table on the hierarchical dataset.
- ◆ Column B – VARIABLE – The variable name on the hierarchical dataset.
- ◆ Column C – VAR_FMT – The name of the SAS format associated with the variable.
- ◆ Column D – LABEL – The label associated with the variable.
- ◆ Column E – FRSVALUE – List of numerical values associated with the SAS format.
- ◆ Column F – FMTVALUE – The value/label of the SAS format associated with the variable.
- ◆ Column G – MINVAL – Refers to the FRS questionnaire, minimum value which the variable can take.
- ◆ Column H - MAXVAL – Refers to the FRS questionnaire, maximum value which the variable can take.
- ◆ Column I – DERIVED – Indication of whether the variable is derived or not. Takes the value of 1 if the variable is derived and 0 if it is not.
- ◆ Column J – PER_VAR –Period code variable associated with amount variable if applicable.
- ◆ Column K – BENEFIT – Benefit key associated with document Benefits. Non-benefit variables take the value zero.
- ◆ Column L – QUESTION – Refers to the FRS questionnaire, source question associated with variable.
- ◆ Column M – TYPE – Whether the variable is an integer (I), floating point (F) or date (D) type variable.
- ◆ Column N – BLOCK – Refers to the FRS questionnaire, block of questions where the variable can be found.
- ◆ Column O – VARSEQ – Refers to the FRS questionnaire and the sequence in which questions are asked.
- ◆ Column P – USAGE – Description of the type of the variable, e.g. frequency, categorical etc. Further information on this (e.g. whether an amount variable has been converted to a weekly value) is held in the document Usage.

Flatfile Mapping

This spreadsheet describes the mapping between the flatfile and hierarchical datasets. The following information is shown:

- ◆ Column A – Flatfile variable name
- ◆ Column B – Full flatfile variable names (expanded list of column A summary)
- ◆ Column C – The source table on the hierarchical dataset
- ◆ Column D – The source variable name on the hierarchical dataset
- ◆ Column E – Usage (amount, categorical etc)
- ◆ Column F – Whether a derived variable
- ◆ Column G – The original question name
- ◆ Column H – The name of the SAS format applied (if required)
- ◆ Column I – Key value (if required), e.g. key to show which benefit
- ◆ Column J – The value of the SAS format applied to key value (if required)
- ◆ Column K – The label applied

The remaining columns show the decode values of the label applied (if required)

Usage

For each variable this gives its type, e.g. frequency, categorical etc. Further information on the codes (e.g. whether an amount variable has been converted to a weekly value) is attached.

Derived Variables Table

This spreadsheet lists all the derived variables (DVs) on the FRS.

- ◆ Column A – TABLE – The source table on the hierarchical dataset.
- ◆ Column B – DERIVED VARIABLE – The variable name on the hierarchical dataset.
- ◆ Column C – DESCRIPTION
- ◆ Column D – CATEGORY NUMBER & Column E – CATEGORY – Gives the area into which the DV falls.
- ◆ Column F – SPEC – The name of the specification which gives further details of the variable
- ◆ Column G – FLAT FILE MAPPING – The name of the flatfile equivalent, which will have the usual flatfile suffixes attached where necessary.
- ◆ Column H – LEAD USER – This may be the group which required the DV, or the purpose for which the FRS team created it.
- ◆ Column I – CHANGES – flags up any changes to the DV since the previous year.

Derived Variable Specifications

This directory contains all the derived variable specifications – showing how they are derived. The *specname* for each DV can be found by using the derived variable table mentioned earlier, but in most cases it is the same as the DV name.

Some variables use constants in their derivation. More information is held in **Derived Variables Metadata**

Documentation for users more accustomed to the FRS

Interviewers Guide to changes.doc

This guide, for interviewers and analysts, highlights questionnaire changes between survey years. The document also covers changes to the wording of particular questions.

Changes Metadata

This spreadsheet shows the variable changes to the hierarchical database that have taken place since the previous survey year and links them to **Interviewers Guide to Changes**. It covers new and dropped variables, rotation of questions and category changes within variables.

Questionnaire Routing

This gives the questionnaire routing, checks and computations in more detail. It is generated from the interview itself and is more definitive than the interviewers' instructions, but is difficult to follow. Once a variable on the database has been identified, this should be mapped to the original question name (using the hierarchical or flatfile documentation). The question name can then be searched for in this document.

Electronic Questionnaire

The questionnaire itself. This is a piece of software which can be installed on your machine so you can work through an interview.

Releases Documentation.doc

Outlines the changes between releases for each survey year.

Editing

Gives details of the types of edits carried out by the DWP

Data summary 1:Missing values

This gives more detail on imputation: the number and percentage of missing values and the method of imputation used for all variables.

Data summary 2:Missing benefit values

This gives more detail on benefit editing: the number and percentage of missing values for each benefit, the number imputed, and the number left as missing

Data summary 3:Min/Max/Mean

A summary of minimum and maximum values.

Accounts Table

Assets Table

These spreadsheets outline the data base structure for the hierarchical ACCOUNTS and ASSETS linking questions asked to variable names.

Assets Table Documentation

Benefits Table Documentation

Technical notes describing these tables.

Benefits

A list of the (adult level) benefit questions with their corresponding benefit key numbers on the benefits table.

Benefits Map

This has two sheets. The first (benefit) outlines the questions asked for each benefit:

- ◆ Column A – BENEFIT KEY – This is key number used for this benefit on the benefit table
- ◆ Column B – ONS/NATCEN KEY – not required for dataset analysis
- ◆ Column C – QUESTION – The initial question asking whether they receive the benefit, as held on the adult table. 1Q2 means it is category 2 of question ben1q, and the answer is held in ben1q2.
- ◆ Column D – BENEFIT - Gives the name of the benefit
- ◆ Column E – ABBREVIATION – an abbreviation of the benefit name
- ◆ Columns F to K – BASIC INFORMATION – This lists the detailed questions which are asked for that benefit. The column headings are the benefit table variables onto which the answer is mapped.
- ◆ Columns L to Q – DOCUMENT CONSULTED INFORMATION – Shows which documents the respondent may consult for that benefit.
- ◆ Columns R to T – USUAL AMOUNT INFORMATION – Shows whether and when this is asked
- ◆ Column U – CURRENT – whether presently receiving the benefit.
- ◆ Column V – CURRENT –how many weeks they have been receiving the benefit.
- ◆ Columns W to AA – WHO GETS – Some disability benefits can be received by one person on behalf another. The benefit will be coded to the person who received it, these variables (WhoRec) show on who they are receiving it for.
- ◆ Columns AB to AF – NON STANDARD QUESTIONS – For some benefits, we wish to hold benefit-specific information. To save space, this information is mapped onto the multi-purpose variables Var<number>. Columns AB to AF show which questions are mapped onto which Var* and the second sheet gives further details...

The second sheet (var) holds details of the multi-purpose variables Var1-Var5 (though not all years require all five). These are used to hold information which is relevant to only a few benefits. For each of the questions shown on sheet 'benefits' cols AB to AF there should be a corresponding bit on this sheet giving the answer formats.

Period Code Conversion.xls

This spreadsheet shows the conversion factors used for weeklyising period variables.

Derived Variable Changes.doc

This document outlines the major changes to, additions and deletions of derived variables from the previous year.

Other documentation available

Interviewers' Showcards.doc.

The interviewers' showcards that are used in various questions when the respondent is asked to say in which of a number of categories they lie. For example, when asked to which ethnic group they belong, they are shown a card with different ethnicities on it.

Pocket Guide to Benefits.doc

The interviewers' pocket guide to benefits, as produced by the survey contractors.

Pocket Guide to Savings.doc

The interviewers' pocket guide to savings, as produced by the survey contractors.

Pocket Guide to Mortgages.doc

The interviewers' pocket guide to mortgages, as produced by the survey contractors.

Analysing the FRS

Hierarchical and flatfile programming

Programs can be written to use either the hierarchical dataset or the flatfile. The programs below come in pairs; they solve the same problem, but one uses the hierarchical dataset, the other the flatfile. The advantage of the hierarchical dataset is that processing is a lot faster, less wasteful of space, and there are fewer variable names to comprehend. In particular two adults in a benunit have two records with the same variable names, while on the flatfile there would be one record with the variables suffixed HD for the head and SP for the spouse. The flatfile does not require a knowledge of the table structure nor require merging of datasets, and it could be argued that it is easier to understand for someone unfamiliar with the FRS.

Grossing

The variable GROSS3 can be applied to sample estimates so that analyses reflect the overall United Kingdom population. This involves the use of a set of adjustment factors that attempt to correct for differential non-response at the same time as they scale up sample estimates. These factors take into account demographic variables such as age, sex and marital status together with region and tenure.

Procedures used

Most FRS analysis can be produced with a combination of proc tabulates, proc freqs and merge and retain statements.

Proc Freqs and proc tabulates produce tables of results. Proc freqs are simpler but less flexible, and the output is less clear.

Merge statements are used with the hierarchical tables. They combine information from different tables.

Retain statements are used to combine different records – for example to look at households with a certain age distribution you would need to compare the records for all adults in the household.

Other useful procedures are Proc format, which combines variables into classes, and ods, which outputs answers to Excel. Using keep statements will speed up processing.

Example 1: Simple breakdown - DLA mobility recipients by employment status

These programs are simple because only one table is required, and only a simple breakdown. If more than one table was required, we would have to use a merge statement in the hierarchical program, and if a more detailed output was required a proc tabulate would be better.

These could then be repeated for other years. Care must be taken to ensure the variables used are consistent, for example in some years there are 14 categories for employment status, in some years 13.

If you only required information on the head of the benefit unit, you could use a where statement (uperson=1) in the hierarchical program, or you could look only at qdlamohd and empbhd in the flatfile program. In this case you could feed the flatfile directly into the proc freq as we have done in the hierarchical program.

Example 1a: Better breakdown - DLA mobility recipients by employment status

There are several ways you can improve the above code. These apply equally to both programs, but the hierarchical program is used for the examples.

First of all, replace proc freq with a proc tabulate to make the output neater:

The 'all' keyword produces a 'total' row and column. The variable before the comma defines the rows, after the comma the columns.

We do not need all the splits. Use a proc format to combine the two 'no' options on ben2q2, and another to label empstatb.

We only have class variables, which restricts the options available to proc tabulate. To get round this, we can either create a dummy variable which is 1 for every case, use another variable as a dummy variable (with great caution!) or use gross2 as a variable rather than a weight.

I shall use sernum as a dummy variable. I know it is on every single record, so it should not create problems. We can now use a weight rather than a freq statement, and can use sumwgt to give us the weighted number of cases. I can add a further column definition after the comma, all*n, which will give us the sample size. This is needed to warn us if the sample size is too small to draw conclusions from, and can be compared with the total number on the original file (eg there are 41842 adults on the 2000-01 file, so if we are looking at all adults we should expect to see this figure as the total sample size).

I have added a keep statement to speed up processing by dropping unnecessary variables.

Example 2: Merging records

Suppose we want to know DLA mobility recipients by household tenure. Tenure information is on the household table, so for the hierarchical dataset we have to merge datasets.

Sernum is enough to uniquely identify the household we wish to attach to the adult record, so we use this to match records:

Note the keep statements – the less information we read over the quicker processing will be.

The resulting dataset is at adult level, as that is the lowest level of any of the input datasets. We insert this into the program we used above:

Tenure information is at benunit level on the flatfile so we do not need to merge. We use the same program as before, using set statements to move from benefit unit level to adult level.

Example 3: Retain statement

Now suppose we want to know how many households contain a DLA mobility recipient, split by tenure type. Our DLA information is kept at adult level (hierarchical) or benunit level (flatfile) so we use a retain statement to move to a higher level.

Flatfile:

Our previous program used three data steps to get down from benunit to adult level. Now we are trying to go up to household level, so we can replace these with a similar retain statement to the hierarchical programs with an 'if' statement which picks up heads and spouses simultaneously.

Example 4: Using imputation flags

Imputation is the process whereby missing values, for chosen variables, are edited to valid values. The main objective of imputation is to maximise the information available to users for analysis. Furthermore, the imputation carried out simplifies the analysis for users and helps to secure the uniformity of analysis created from the FRS datasets.

The editing process is carried out on cases where a value has been given but following checking is believed to be incorrect, for example where a respondent has given a benefit amount which is not valid.

When imputation and editing are undertaken, transactions are applied to a copy of the dataset to ensure that the original dataset can still be accessed in its unaltered state. Transactions change the old value in the copied dataset to a new value, but they do not make any changes to the original dataset. Transactions allow the user to follow the audit trail and see how the values have been changed. The transactions are saved in a transaction dataset, which records the table, variable, serial number and related key variables, the old value and the new value of the record which has been changed.

For example if the variable ABSPAR (whether receiving any allowance from an absent partner) was changed from a 'don't know' response to a valid response of 'no' then the transaction would read:

 New_val=the new imputed/edited value which will be recorded in the release 1 dataset (2='no').

Using the transaction dataset it is possible to create your own imputation flags, as and when necessary, for whichever variable required. The transaction dataset can be merged with the FRS dataset to examine whether an individual case has been edited. The SAS program below is an example of how the transaction dataset can be accessed and imputation flags created.

It should be noted that transactions are applied to the hierarchical dataset and therefore transactions can only be accessed via the hierarchical dataset and not the flatfile.

An alternative way to examine whether imputation has been carried out on a particular case is by setting up an imputation flag manually and comparing the pre and post imputation files. Using this method will not provide as much information but can be used on both the hierarchical and flatfile. The SAS program below is an example of how the imputation flags can be created using the flatfile.

Grossing factors for National Statistics from DWP Family Resources Survey

Department for Work and Pensions statisticians, in consultation with other departments, have been reviewing the grossing methodology for the DWP Family Resources Survey (FRS). The FRS is used as a source for National Statistics on income distribution and on the take-up of income-related benefits.

The current FRS grossing regime ensures that FRS-based estimates for Great Britain match population estimates derived from other National Statistics sources. However the regime has not sought to ensure that estimates for individual countries or regions match population estimates for those countries or regions. In practice estimates have not always matched. As a consequence, it has not been possible to produce reliable estimates of the **number** of individuals in households below various income levels for countries or regions.

As a result of the working group discussions, DWP statisticians envisage – subject to consultation – adopting a grossing regime which will:

- take account of the revision of population and related estimates in the light of the 2001 Census, once these revisions are made;
- take account of new evidence, expected next year, from comparisons of Census data and FRS data; these comparisons will be conducted by the Office for National Statistics;
- and, if possible, match FRS-based estimates for all countries and regions to official population estimates.

This cannot be implemented in full before next year. Given the demand for more robust low income estimates for Scotland, an interim grossing regime has been developed which matches to both GB and Scottish population estimates. The new interim regime will allow estimates of **numbers** of individuals below various income thresholds, in Scotland, to be published. The effects on estimates of the **percentage** of individuals below various income thresholds are small. (See note 4 in Notes for Editors.)

The new interim regime yields estimates, for low income counts in Great Britain, which are identical or very close to previously published estimates. (See note 2 in Notes for Editors.) DWP statisticians intend to revise Great Britain low income estimates in due course and will consult users of low income statistics as to the timing of this revision. In the meantime the estimates published in the last edition of Households Below Average Income, and the database underlying those estimates, remain the recommended source of information on patterns of low income for Great Britain. The Scottish Executive are today publishing estimates for Scotland, consistent with the new interim regime. Thereafter, all analysis specific to Scotland will be based on the new interim regime.

DWP statisticians will consult the users of other FRS-based National Statistics published by the Department on the application of a new grossing regime to those statistics.

Notes for Editors

1. The Family Resources Survey (FRS) collects information on the incomes and circumstances of private households in Great Britain. The survey covered around 24,000 households in 2000-01. The FRS grossing regime allows FRS data to be scaled-up to provide estimates of the numbers of households, in Great Britain, with various characteristics – e.g. with income below the national average. The process of grossing involves scaling-up the FRS to estimates of population, households and to a number of other key totals which come from a variety of National Statistics sources. Several Government Statistical Service surveys adopt this approach to weighting survey data.
2. The following table shows what would be the impact, of adopting the new interim grossing regime, on key low income estimates for Great Britain published in Households Below Average Income. Figures are presented under the new interim grossing methodology and changes from published estimates are marked in superscript.

Grossing factors for National Statistics from DWP Family Resources Survey

Department for Work and Pensions statisticians have been reviewing the grossing methodology for the DWP Family Resources Survey (FRS). The FRS is used as a source for National Statistics on income distribution and on the take-up of income-related benefits.

The FRS grossing regime used to date has ensured that FRS-based estimates for Great Britain match population estimates derived from other National Statistics sources. However the regime has not sought to ensure that estimates for individual countries or regions match population estimates for those countries or regions. The exception is Scotland, where an interim regime announced in 2002 introduced improved population counts for Scotland. As a consequence, it has not been possible to produce reliable estimates of the **number** of individuals in households below various income levels for countries – other than Scotland – or regions.

A new regime has been devised, which improves the accuracy of regional-level counts drawn from the FRS. Other changes are expected to improve the accuracy of national counts; they deliver a better match with population estimates from the Office for National Statistics (ONS). The new regime aligns FRS grossing factors to ONS population estimates of individuals by age, sex and region. The previous regime controlled for numbers of singles and couples, based on applying fixed cohabitation rates derived from historical data to ONS population estimates by marital status. Although the new regime still controls for numbers of lone parents and overall number of families with children (based on a combination of survey and DWP administrative data), overall cohabitation rates in FRS results are now more a reflection of survey findings than of external constraints on the grossing.

DWP statisticians have also incorporated changes in population counts, and related counts, following the 2001 Census. The post-Census revisions reduced the estimated number of males by around three quarters of a million – of whom around half were in the 25-39 age group – and the number of females by around 100,000.

Revised grossing factors, incorporating both the new grossing regime and the revised population counts, have been calculated for all the years for which full-year FRS data is available, from 1994-95 onwards.

Implications for FRS-based National Statistics released by DWP

Family Resources Survey annual report

The next annual report, on the 2003-04 dataset, will employ the new grossing regime and population counts. There will be no revisions to previous reports; each report covers a single year. The report will include details of the new grossing regime methodology and will highlight any significant changes outside those expected due to the regime change. Datasets with revised grossing factors will be available to FRS users through the normal channels, for all years from 1994-95 onwards.

Households Below Average Income (HBAI) statistics

The full FRS-based series, from 1994-95 onwards, will be revised to incorporate both the new grossing regime and the revised population counts, when results for 2003-04 are released on 30 March 2005.

DWP statisticians have consulted external experts on an issue concerning the monitoring of progress on the Public Service Agreement target to reduce child poverty. The relevant PSA Technical Note stated that this target would be monitored via HBAI, using the HBAI '1998/99 baseline figures and methodology.' The revision of population counts does not constitute a change in HBAI methodology; but it could be argued that a change in the FRS grossing regime does constitute a change in methodology. Following the consultation with external experts, DWP statisticians have decided that the main results in HBAI should employ the

new grossing regime; while key results, using the most up-to-date population counts but the previous grossing regime, will be provided in an appendix.

The view of DWP statisticians, in relation to income statistics, is that results using the new grossing regime are likely to be more accurate at national, as well as regional, level, and should be used for all purposes.

Pensioners' Incomes series

The 2003-04 edition of the Pensioners' Incomes series will include revised results from 1994-95 onwards, incorporating the new grossing factors and population counts. This will be released on 6 April 2005.

Take-up of income-related benefits

The next, and subsequent, editions of the statistics on the take-up of income-related benefits will employ the new grossing regime and revised population counts. As the estimates of take-up routinely allow for imperfections in the FRS grossing regime, the effects are expected to be small, for many results; but may be larger for others. The next edition in the series, or a separate press release, will report on the effects of the new regime and population counts.

The process of grossing involves scaling-up the FRS to estimates of population, households and to a number of other key totals which come from a variety of National Statistics sources. Several Government Statistical Service surveys adopt this approach to weighting survey data.

3. There has been no change in the grossing regime or population counts used for Northern Ireland, which was added to the FRS in 2002-03.
4. The new regional regime aligns FRS-based estimates to regional populations by age and sex. This should improve regional and national estimates in instances where differential responses by age, sex and region are a significant influence on the accuracy of the statistics concerned. But some elements of the grossing system are only applied at national level; other factors potentially related to non-response do not enter the grossing at all; and sample sizes are smaller at regional level. For these reasons, regional results based on the FRS still need to be treated carefully.
5. The change in the grossing regime entails changes in the selection of types of counts – e.g. whether these are regional or only national – for which DWP statisticians seek to align grossed FRS counts with counts from external sources. The change in population counts entails changing the numbers in these external counts. Both changes are being introduced at the same time, to minimise the volume of revisions to FRS-based statistics.
6. For the HBAI low-income statistics, the effects of grossing changes on previously published counts of children, working-age adults, pensioners and 'all individuals,' below 60% of median income, have been investigated. 'Below 60% of median income' is a commonly used indicator of low income or poverty. The effects of the change in grossing regime alone are small. In any one year, changes in percentages do not exceed 1 percentage point; changes in numbers do not exceed 0.1 million for children, working-age adults or pensioners and 0.2 million for 'all individuals.' In general, the effects on any given published series in different years are zero or all in the same direction; exceptions are numbers of working-age adults, for income before and after housing costs, and numbers of children and 'all individuals,' for income after housing costs. The combined effects of the change in the grossing regime and the revised population counts are modest. In any one year, changes in percentages do not exceed 1 percentage point; changes in numbers do not exceed 0.1 million for children, 0.2 million for pensioners and 'all individuals,' 0.3 million for working-age adults; from 1996/7 onwards, the effects on any given published series in different years are zero or all in the same direction.

FRS GROSSING REVIEW: BACKGROUND NOTE

1. Grossing regimes for sample surveys scale up the survey figures to allow estimates to be presented for the total number of people with a given characteristic; and to correct, as far as possible, for any biases due to some groups being less ready to take part in the survey than others are. After the launch of the Family Resources Survey (FRS) in 1992, DSS statisticians devised a grossing regime that seeks to correct for response biases in relation to age, gender, lone parents/all families with children, housing tenure and Council Tax Band - these last 2 aspects being a proxy for income. It does this by scaling up the sample counts to match independent 'control totals.'
2. An FRS grossing review was launched last year – to run in parallel with National Statistics quality review of Households Below Average Income (HBAI) statistics and Pensioners' Incomes (PI) statistics. This was to allow us to synchronise timings, to avoid having to change HBAI/PI results one year in response to HBAI/PI review recommendations and again, shortly thereafter, due to a revised FRS grossing regime. A formal Working Group - with members from DWP, Office for National Statistics, Scottish Executive and Inland Revenue - was set up earlier this year.
3. The Working Group identified an urgent need in relation to Scotland. Plausible estimates of the number of children in households with income below eg 60% of the median income – in Scotland, could not be prepared by the Scottish Executive (SE) using DWP's Households Below Average Income (HBAI) dataset. The figures jumped around from one year to the next, because HBAI's estimates of the *total* number of children in Scotland fluctuate implausibly. This is because the FRS grossing regime uses control totals for Great Britain, not for individual countries or regions; so it does not correct for year-on-year variations in response rates at country/region level. As a consequence, SE statisticians had to refrain from releasing results for the **number** of children in "poverty" in Scotland; and rely only on results for the **percentage**, which are published in HBAI. This issue had been raised in the Scottish Parliament, and SE Ministers had indicated that the problem would be addressed in time to present numbers in this year's Social Justice Annual Report, due for publication on 18th November.
4. The Working Group have considered:
 - the Scottish Executive's urgent needs; and longer term needs for sub-national results, given growing interest in results for English regions and Wales;
 - census-linked revisions to control totals – each of the departments producing control totals, used for FRS grossing, will be revising these in the light of results from the 2001 Census;
 - the vital role foreseen for the Census comparison study - our first opportunity to secure definitive estimates of FRS response biases, using 2001 Census data for non-respondents.

- other known deficiencies in the current grossing regime, including the need for accurate and consistent counts of (families with) children in place of the Child Benefit series currently in use.¹
5. The second component has become even more significant than officials expected in the summer, in the light of the significant changes to population estimates, stemming from the 2001 Census, announced by ONS a few weeks ago. The third component is particularly important because evidence emerging this year suggests that the FRS overstates the proportion of people in workless households.² This is likely to affect HBAI's low income estimates for any one year (though the effect on estimates of changes over time should be much smaller). At present we cannot quantify this overstatement, and therefore we cannot correct for it. We should be able to, when we have the results of comparisons of FRS data with Census data – the latter will include households who declined to give FRS interviews, and so will allow us to quantify non-response biases in the FRS.
 6. The sophistication of the FRS grossing regime, with its multiplicity of controls, stands us in good stead in many ways. But we now stand to pay a price for it:
 - The various control totals will all be updated in the light of new data from the 2001 Census.
 - But different control totals will be updated, by various Departments/teams, at different times over the next few years.

So if we took new information on board as soon as each tranche become available, given that we have just revised (to address Scottish Executive needs) we would be faced with revising HBAI and possibly other FRS-based statistics in each of three or four successive years.

7. The desirability of using the best data available at any one time has to be weighed against the undesirability of a succession of revisions to FRS-based statistics. The latter would be resource-intensive. They could also undermine confidence in the statistics - especially as we could not always guarantee that the revisions would take us closer to the truth, if we define this as the results that will emerge when all the revisions currently contemplated have been implemented.

¹ Child Benefit data is used as a proxy for the number of children. In this context it has a discontinuity, as more recent data understates the number of very young children

8. The Working Group considered a wide range of options and proposed the following strategy for the FRS grossing regime:

Stage A No more than modest revisions in the 2002 grossing round, feeding into the 2001/2 income statistics to be released next year, and into Scottish Executive results (to 2000/1) to be released in November.

Stage B. Major revisions in the 2003 grossing round, incorporating new (2001 Census-based) population estimates and the results of the FRS/Census comparisons. These revisions cannot be introduced sooner, because the data will not be available. Conversely, delaying them would delay our remedying of known deficiencies in FRS-based results; this would be difficult to justify.

Stage C. Final Census-based revisions in the 2005 grossing round.

7. For Stage A, DWP statisticians have devised a regime that considerably reduces spurious volatility in grossed population estimates for Scotland. It also adopts a consistent time series for the number of families with children, in Scotland and in Great Britain. The effects on results for Great Britain are very small.³

³ In relation to the PSA target on child poverty, which is monitored via HBAI estimates of the number of children in households with income below 60% of the median income in Great Britain, the new grossing regime leaves unchanged the published figures for 1998/9 – the baseline year – and for the latest available year, 2000/1.

Introduction and Summary

This paper describes the changes being made to the Family Resources Survey (FRS) grossing regime, and compares the results of the old and new regimes for key statistics based on the FRS.

Details of the new and old regimes are provided, together with an outline of the investigations undertaken that led to the new regime. This is followed by analysis of the effects of the changes in the regime on key statistics.

The key changes to the grossing system are:

- a move to post-Census data
- the abandonment of controls on numbers of couples and single people by broad age band in favour of controls on numbers of individuals by narrower age band, and sex
- the introduction of population controls at Government Office Region

Grossing factors based on the new system have been issued with the 2003-04 FRS data. These incorporate both an enhanced set of control totals and data on a post-Census basis.

The new regime does take on board the results of the 2001 Census, through the control totals used, to the extent that this was possible at the end of 2004. Some pre-Census figures have been used for the total number of households, pending revisions to historical data up to 2000 and household projections beyond 2002. All other figures are post-Census (or not affected by the Census, e.g. because they are based on administrative or other data).

This review has focussed on the Great Britain grossing regime; the regime employed for Northern Ireland grossing is not affected by these changes.

Background

Since 2000, Department for Work and Pensions statisticians, in consultation with other departments, have been reviewing the grossing methodology for the DWP Family Resources Survey (FRS).

As part of this review an interim grossing regime was introduced in December 2002 with the release of the 2001-02 FRS. This was a modest revision primarily targeted at improving low income estimates for Scotland.

Further work was also commissioned to look at other areas of concern and interest. These included the potential for introducing regional controls to improve the

robustness of FRS analysis at a Government Office Region (GOR) level; the potential for addressing the perceived bias in terms of worklessness in the FRS compared to the Labour Force Survey (LFS); and the potential for abandoning the use of cohabitation factors in the derivation of controls from population estimates.

This additional review work has now been completed and has resulted in a new grossing regime. The following sections set out the previous and new methodologies, summarise the findings of the review work, and describe the impacts of the changes.

The previous FRS grossing regime

The regime in place up to and including results from the 2002-03 FRS, used the following control totals:

For Scotland separately, and England and Wales (combined):

- Single males <35
- Single males 35-59
- Single males 60+
- Couples, males aged <65
- Couples, male aged 65+
- Single females <35
- Single females 35-64
- Single females 65+
- Total dependent children
- Total Families with children

At GB level:

- Male lone parents
- Female lone parents

Total households analysed three ways:

- By broad Council Tax band
- Geographically – London, Scotland and “the Rest of England & Wales”
- By tenure

The controls at Scotland level were introduced with the 2001-02 FRS dataset, as an interim solution to issues raised by the Scottish Executive regarding monitoring of children in poverty [the numbers were proving volatile before Scotland-level controls were introduced].

The new grossing regime

The main changes in the new grossing regime are a shift to population counts by age and sex, and a breakdown of the population estimates to GOR level. The control totals are as follows.

At GOR level:

- Males in the following age groups:
 - 0-9
 - 10-19 dependents
 - 16-24 non-dependents
 - 25-29
 - 30-34
 - 35-39
 - 40-44
 - 45-49
 - 50-59
 - 60-64
 - 65-74
 - 75-79
 - 80 plus

- Females in the following age groups:
 - 0-9
 - 10-19 dependents
 - 16-24 non-dependents
 - 25-29
 - 30-34
 - 35-39
 - 40-44
 - 45-49
 - 50-59
 - 60-69
 - 70-74
 - 75-79
 - 80 plus

For Scotland separately, and England and Wales (combined):

- Total Families with children

At GB level:

- Male lone parents
- Female lone parents

Total households analysed three ways:

- By broad Council Tax band
- Geographically – London, Scotland and “the Rest of England & Wales”
- By tenure

The new regime is therefore a mixture of some controls at a GOR level, some at a GB level, and some that separate out Scotland and in one case, London: only the population counts are at GOR level.

The findings of the review

Cohabitation vs a finer age breakdown

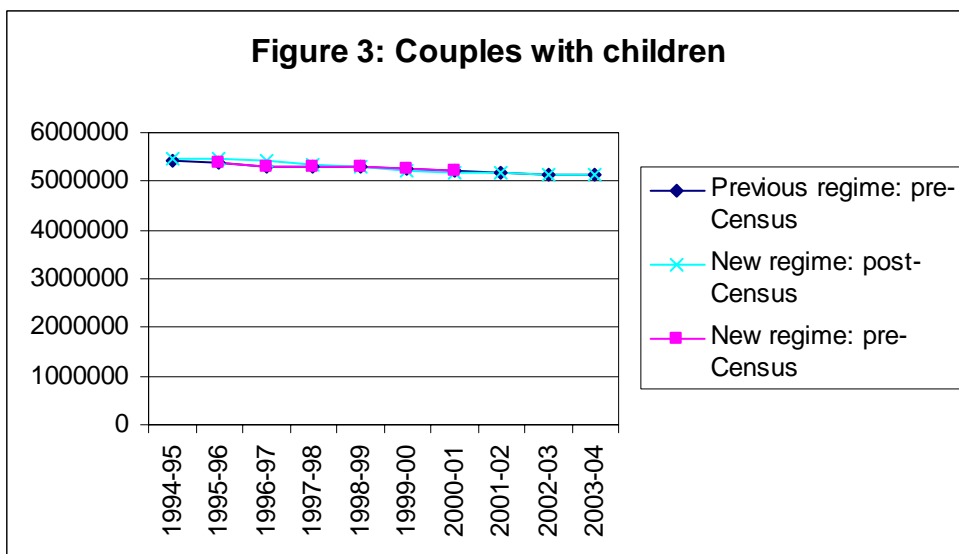
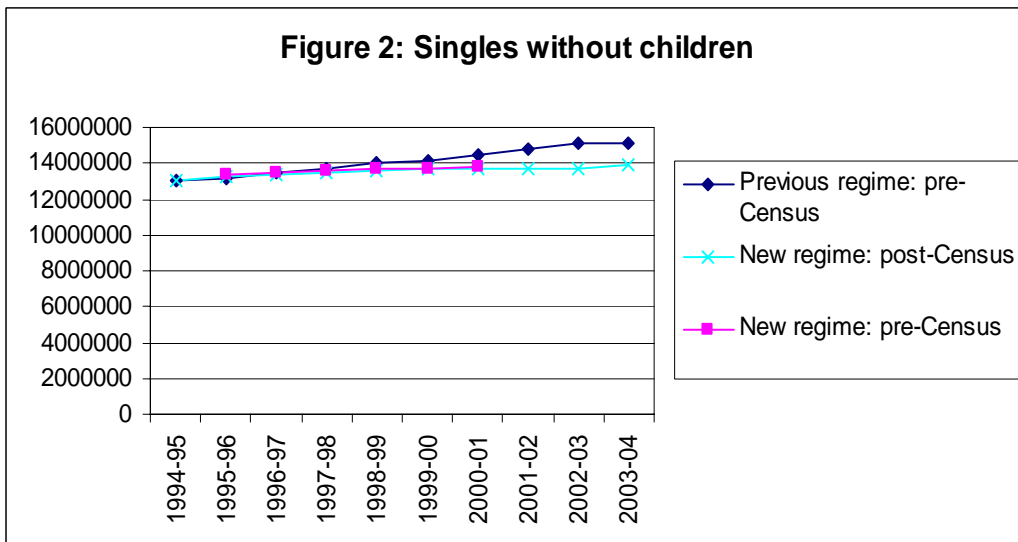
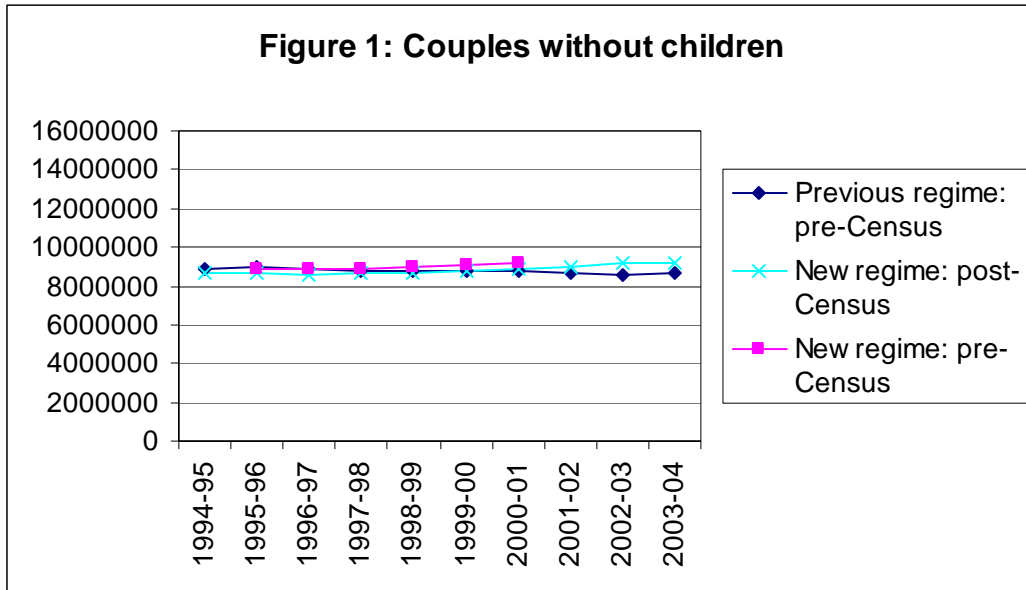
The first area considered was whether we could move from grossing based on family units (singles and couples) towards numbers of individuals by age and sex, using a finer age breakdown. The main reason for this question arising was the way in which estimates of numbers of couples and singles were derived. The designation of “singles” and “couples” needed to be based on living arrangements rather than [legal] marital status. The calculation of these controls was based on population estimates by legal marital status, available routinely from the Office for National Statistics (ONS), together with a set of “cohabitation factors” which were used to adjust the legal marital status estimates to a de facto marital status basis. These cohabitation factors were based on data from around 1996, with the result that the FRS was effectively being constrained to 1996 cohabitation rates.

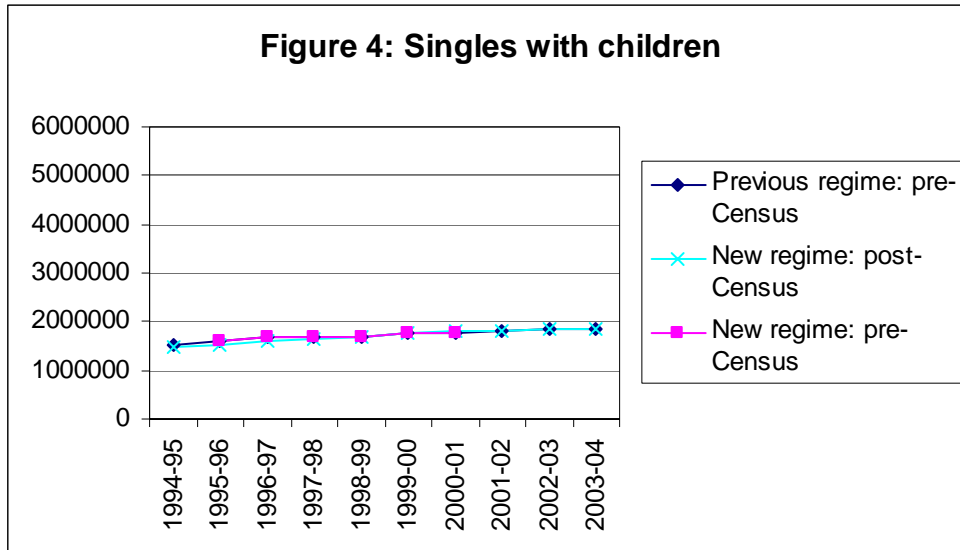
An alternative methodology, proposed by ONS methodologists, was to move towards controls based on counts of individuals by age and sex, which would mean that the cohabitation pattern would not be constrained [or at least not directly].

Evidence from this stage of our analysis indicated that when we constrained to individuals rather than family groups, we saw different trends from when we constrained the grossing to family groupings. Our inference was that the FRS was exhibiting variations in cohabitation rates over time, and given the corroborative evidence from other sources, we concluded we would therefore be better off using population counts by age and sex, rather than family groupings.

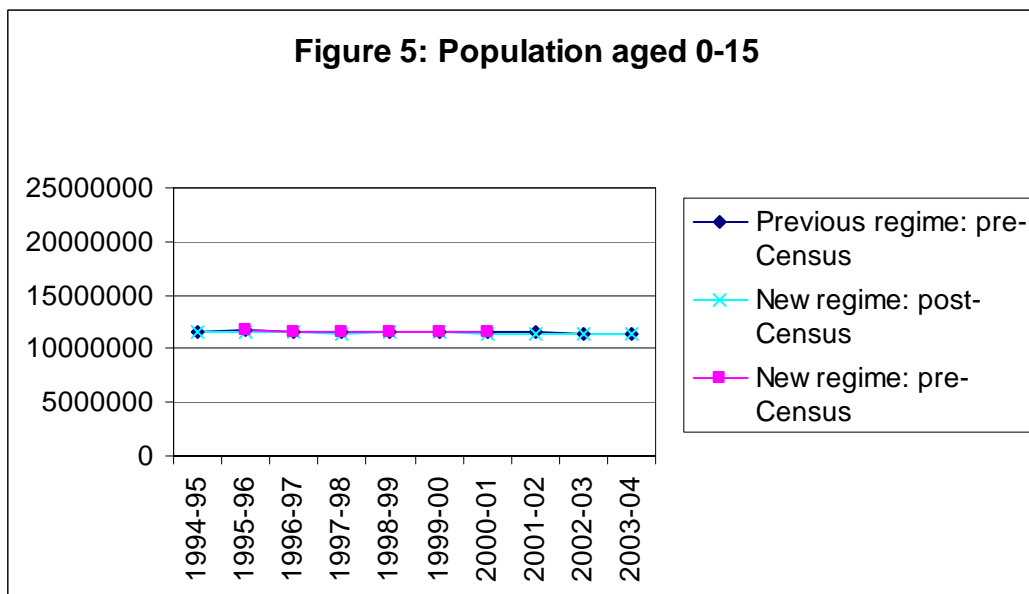
The impact of the changes to the grossing regime in terms of numbers of couples and singles is illustrated in the following charts. The results for the ‘new regime pre-Census’ do not cover the full period, due to the availability of the required information.

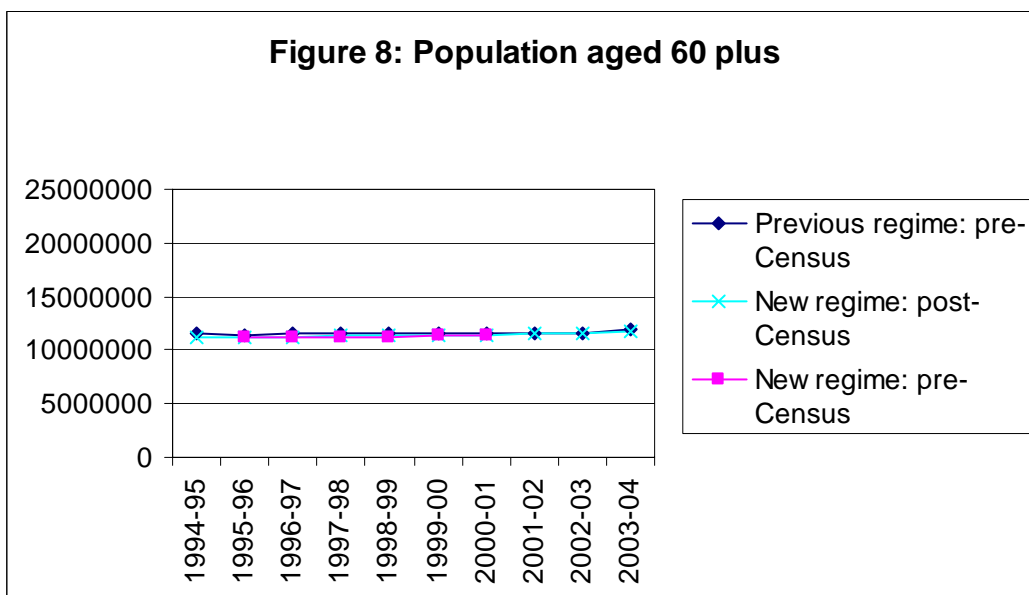
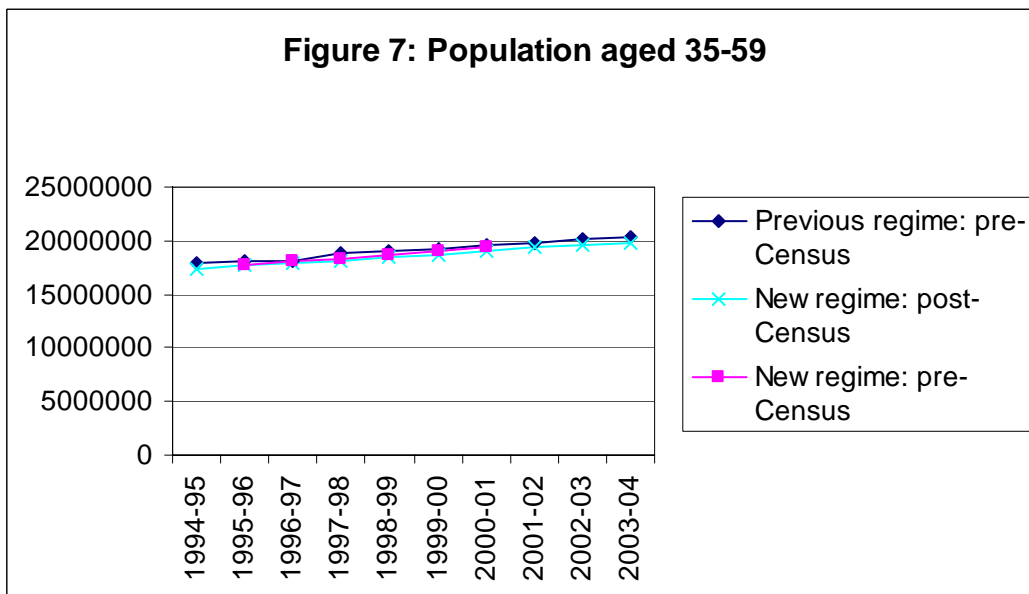
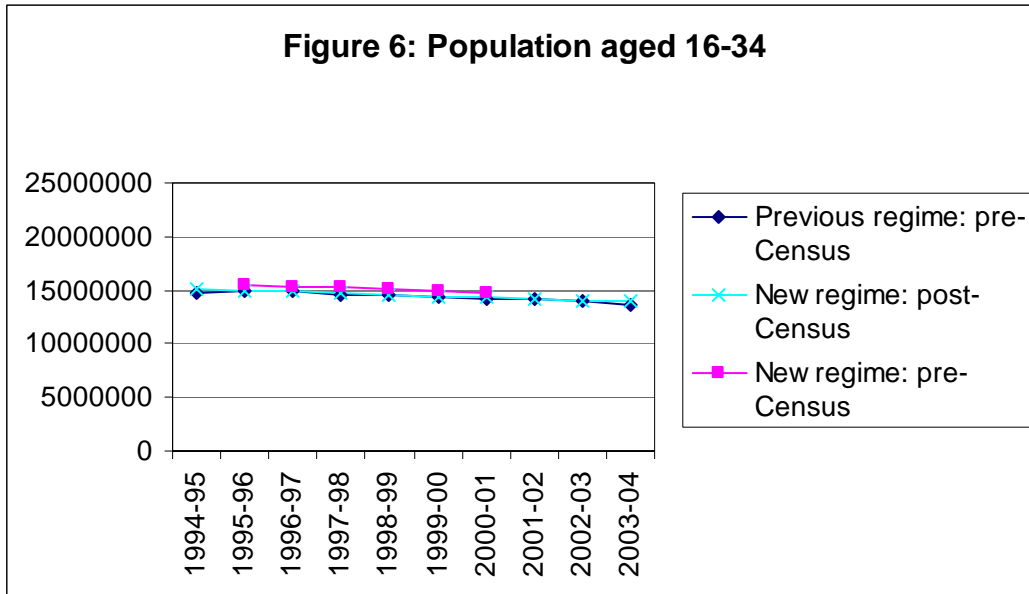
Note that both previous and new regimes use controls on singles with children (ie. lone parents) and families with children (which effectively means that couples with children are fixed as well): the latter comes from administrative data and is therefore not subject to changes emanating from the Census. Therefore changes in the series for singles or couples with children are due to changes in estimates of lone parents. These changes are due to updated and improved methodology, rather than the Census.

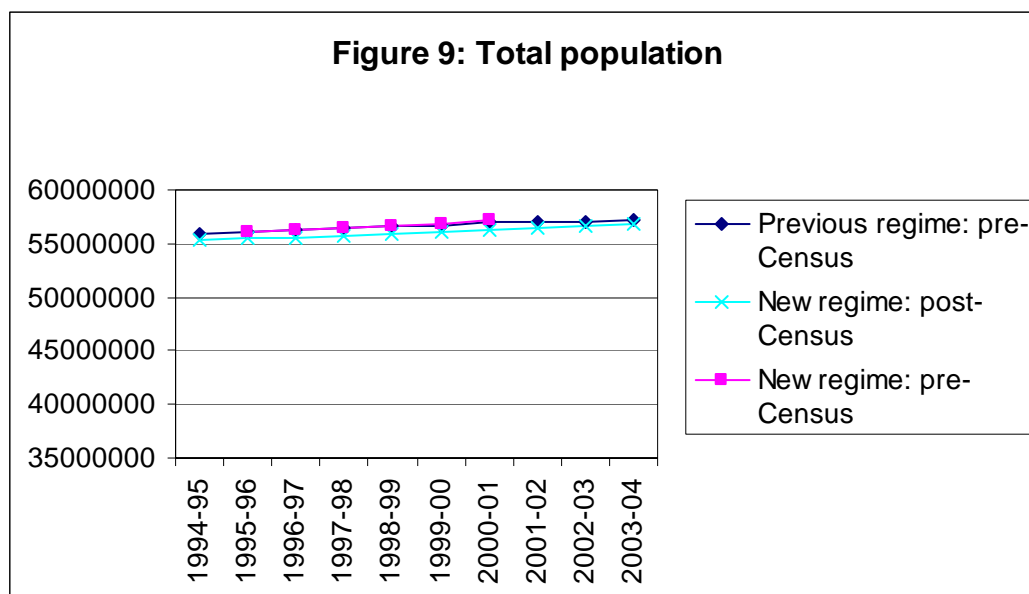




The move towards using counts of individuals rather than units has had some impact on counts of individuals derived from the FRS of course, though these are not drastic, as the following charts illustrate.







Worklessness

The second area considered by the review was whether we should adjust the FRS grossing for any potential response biases in terms of worklessness. This question arose from comparisons between the results of the FRS with those of the Labour Force Survey (LFS), with FRS indicating higher worklessness than the LFS. There was also information from the FRS non-response module [an additional set of questions asked of those who refused to take part in the main FRS questionnaire, aimed at getting basic information on household composition], which could potentially be used to adjust the main FRS results, provided we were safe in assuming that those completing the non-response module were representative of all non-responders i.e. including outright refusals and non-contacts. Results from the FRS non-response module indicated that workless households were more likely to respond to the FRS.

A key input here was to be the Census non-response work conducted by ONS, which would give an indication of the reliability of the FRS non-response module. As part of the follow-up to the Census, ONS conducted an exercise to match samples from Government surveys, including the LFS and FRS, to Census records in order to assess response biases. This involved matching of the FRS and LFS samples (including non-responding households) for the period around to Census, to the Census itself. To inform the FRS review, ONS were specifically commissioned to report on levels of worklessness in their studies of non-response for FRS and LFS.

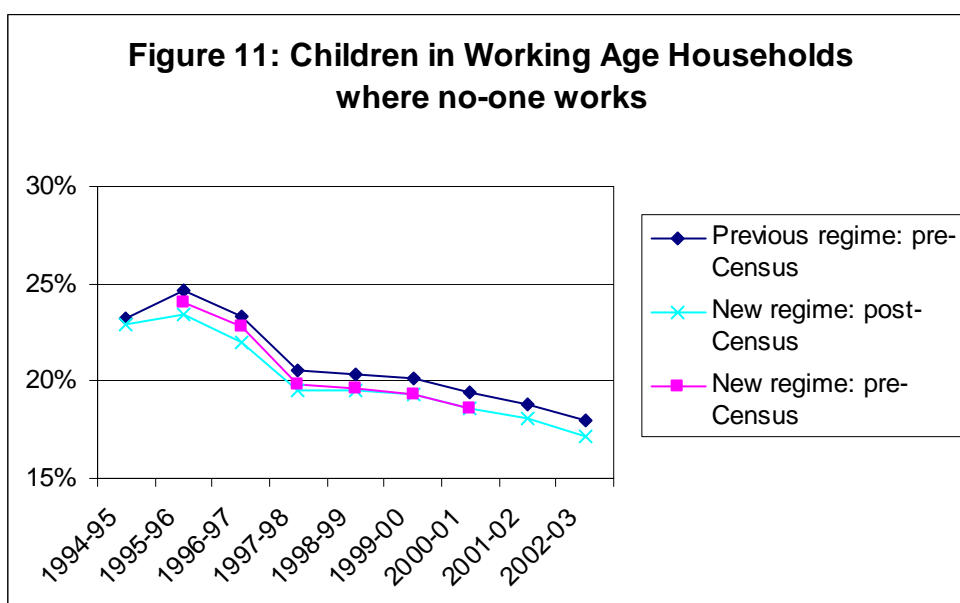
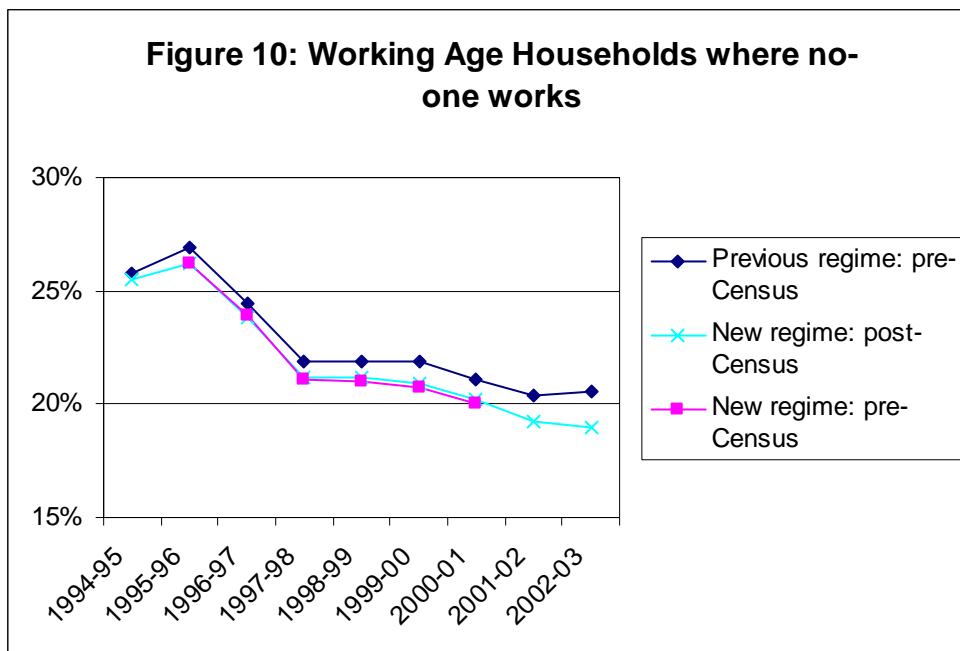
This work concluded that there was no direct evidence of a response bias in the LFS as regards worklessness for any subgroup, whereas there was evidence of response bias on the FRS, with lone parent households less likely to respond if anyone is working, and households without children more likely to respond.

Importantly however, the exercise also indicated significant differences between FRS non-responders who completed the non-response module, and those who refused or

who could not be contacted at all – the implication being that we could not reliably use the non-response results to adjust the FRS for any worklessness bias.

Our conclusion was therefore that for the time being we could not adjust for worklessness, but in the longer term we will consider using LFS worklessness results to adjust the FRS.

The new regime does however have some impact on worklessness counts, as the following charts show. Overall the proportion of working age households where no-one works has reduced, as has the proportion of children (aged 0-15 in Figure 11) in such households.



Regional grossing

The third area that the review considered was whether we could move towards using controls totals at a Government Office Region (GOR) level, given the increasing interest in area-based statistics and the moves already made (in terms of separate FRS results for Scotland, and Northern Ireland having its own survey).

The findings from the analysis undertaken here were that there seemed no technical grounds for not using regional population controls. The software used to produce grossing factors – the “calmar” algorithm put together by INSEE, the French national statistical institute – could be adapted to use the increased number of controls, and the algorithm still “converged”, meaning it could produce a set of viable grossing factors from the sample datasets and the various control totals provided to it. Population counts at a regional level were of course found to be more stable, although results do need to be treated with caution: the new regime is not a full-blown regional regime and sampling and response rate variations between regions will still affect regional-level estimates of sub-groups derived from the FRS.

Family Resources Survey

Description of files provided with the ASCII export format

General

All files are provided in comma separated value (csv) format.

All files include a comma separated list of column names as the first row

For each *table* in the FRS hierarchical data structure, two files are provided - *table.dat* & *table.dic*.

One other file is provided - *vallabs.fmt*

Table.dat

The first columns contain the key variables in order of key, these are followed by base survey variables in alphabetical order, and then by additional derived variables in alphabetical order.

SAS Missing values are represented as follows :

- A** - Skipped
- B** - Don't know
- C** - Refused to answer
- D** - Unable to derive - (Applies to derived variables only)

Dates are represented in DD/MM/YYYY format.

transact.dat (special case)

Editing transactions are stored in a SAS dataset. This is also exported in ASCII format with the other survey data files. However, it should be noted that the representation of the data differs slightly from the other data files as follows:

- It contains some alpha-numeric variables (denoted by type=(**A**) in the *transact.dic* file)
- Dates are represented in DDMMYY:HH:MM:SS format.
- Skipped variables are represented by a dot for numeric variables, and a space for alpha-numeric variables
- In the variables *old_val* & *new_val*, representing the values before and after the transaction is applied, the skipped values **A**, **B**, **C** & **D** are represented by the negative numbers **-1**, **-9**, **-8** & **-2** respectively. (This is because transactions are stored initially in an Oracle database, where character representations for missing numeric variables are not allowed)
- Some transactions exist solely to create or delete benefits records. In these, the words **INSERT** or **DELETE** will appear in the *frsvar* variable, and dots will appear in the *old_val* & *new_val* variables.

Table.dic

These files contain selected data dictionary items for each table - (one row for each variable)..

The variables (rows) are listed in the same sequence as their column sequences in the data files.

The dictionary columns are listed and described below :

- Table** - (Just confirms which table the information relates to)
- Variable** - Variable name
- Type** - (I), (I2) = Integer, (F), (F1), (F2) = Floating point, (D) = Date, (A) = Alpha-numeric
- Key** - If a key variable, it's position in the key sequence (sernum=1, benunit=2 etc.)
Otherwise undefined (represented by a dot)
- Minval** - Minimum value - (based on original survey data - not always present)
- Maxval** - Maximum value - (based on original survey data - not always present)
- Width** - The field 'width' of the original survey data variable, before conversion to our hierarchical database structure - (It might be useful for some purposes)
- Var_fmt** - The name of the SAS Format (i.e. set of value labels) as listed in the file *vallabs.fmt* (see below)
This provides value labels for most categorical variables
- Label** - Variable label or description - where available

Vallabs.fmt

In the FRS database, a SAS 'format' refers to a named set of value labels, which can be associated with one or more variables. In the vallabs.fmt file described below, each value, within a named format, occupies a single row.

The file contains no table or variable information. SAS 'Formats' are associated with variables by format name only. This association can be made by relating *fmtname* in the vallabs.fmt file to *var_fmt* in the *table.dic* files.

The formats meta-data may appear to be listed approximately in alphabetical order of the tables with which the formats are associated. But this effect is coincidental. The strict sequence is by alphabetical order of format name.

Fmtname - Format name - can be associated with *var_fmt* in the *table.dic* files described above
Start - Minimum value of range associated with label
End - Maximum value of range associated with label
(In practise, most of our value labels are for categorical variables, and so ***Start & End*** are the same)
Label - Label describing the value, (or range of values)

Family Resources Survey

Procedure for creating SAS system files from SAS transport files

Background

Our policy is to transfer SAS data as SAS transport files, using PROC COPY with the SAS XPORT engine. This makes it possible for recipients to import the data into a variety of SAS versions, on a variety of platforms.

Points to note:

1. The formats catalogue is also exported as a SAS transport file, and will need to be converted back into a formats catalogue. (see below)
2. The SAS transport files are binary files, and it is important that you use binary mode when transferring them across platforms.
3. These files are created from SAS 6.12 running on DEC Alpha system running Digital Unix V4.0

The export process

The procedures used to create the dataset and formats catalogue exports are outlined below:

NB. The occurrences of & below, indicate where a specific name should be substituted, or a macro variable set.

The import process

The import process is basically the reverse of the export process, using PROC COPY with the XPORT engine. The following code provides an example of how you could carry out this process.

Procedure for creating SPSS system files from SAS export files

The procedure outlined below may be used to create SPSS system files from SAS export files. The GET SAS DATA command in SPSS provides the basis for this procedure. However, certain tweaks have also been added in order to produce useable SPSS files.

Reasons for needing special procedures:

Software

Certain versions of SPSS (e.g. SPSS for UNIX version 5.0) do not properly support the 'formats option' within the GET SAS DATA command. SPSS won't necessarily give an error when you try to use the formats option in such circumstances, but you will find that the option doesn't actually do anything. 'Formats' adds value labels and output formats to variables in the SPSS system file.

One user found that they had an 'incapable' version of SPSS operating on their UNIX platform (where the files were eventually to be stored), but used a more recent version of SPSS (Version 6.1.3 for Windows, operating on a desktop PC) to create useable SPSS system files. These files were then posted back to their UNIX platform using a file transfer program.

Users who find it necessary to use a desktop PC should be aware that this computer will need a sufficient amount of storage space. To convert a file, the computer will need enough space to hold at least - each **.spx** SAS export file, a **Formats.spx** formats file (if required), and the resultant **.sys** SPSS system file

Missing values

GET SAS DATA cannot convert SAS user-missing values into SPSS user-missing values. Instead, all SAS missing codes are converted to system missing in SPSS. The SAS export files are therefore provided by the DSS with any missing values set to real, negative numbers as follows:

Skipped	-1
Refused	-8
Don't Know	-9
DV - Missing data	-2

These values are then specified as SPSS user-missing values during the conversion procedure.

General procedure to be used for all files.

1. If the computer which is being used to create the SPSS system files cannot read files directly from the CD-ROM/Floppy disk, use a file transfer program to copy the file entitled **Formats.spx** (if required) and the **.spx** file(s) you wish to convert onto the hard disk of this computer. NB. The **.spx** files should be transferred as binary files.

2. In SPSS, run the following command syntax to create each SPSS system file:
