

## 2008 Questionnaire Changes

#### **Adlearn7/Adlear7n**

Shortfalls were noted in Adlearn7 whereby some respondents who had attained educational qualifications over the last 12 months were omitted from the results. This variable has now been reformatted and is titled Adlear7n. Data for JD07 has also been reformatted to ensure continuity.

#### **Cured8**

The cured (current education received) derived variable has been updated to include changes that were made to the learning variables in 2008.

#### **Durun**

The Durun (duration of unemployment) derived variable has been updated to include changes that were made to government training scheme variables in 2008.

#### **Travel to Work.**

Due to an error in the Blaise programme, 12 variables which should have been included in the enhanced sample were included in the main sample only. SVS has therefore included these variables for 2008. These variables are **Drivl, DRFP, Dityp, Trleave, TRefEmp, TRefT(1-10), TDifEMP, TrdSame, TDifT(1-6), TrvTme, TrvMth and TrvDrv.**

In 2008, 2009, 2012 etc these questions will be asked in waves 1 and 5, all quarters, for the main sample. For the enhanced sample they will be asked in waves 1 to 4 all quarters.

In 2010, 2011, 2013 etc the questions will be asked in October – December quarter for the main sample (waves 1 and 5 only).

### **National Identity and Welsh Language data.**

As they are not expected to change over the period of participation in the survey the National Identity and Welsh Language questions are asked only at the first contact with each household, regardless of at which wave the first contact is made. This information is automatically rotated into every subsequent interview with that household.

In Jan-Mar08 these questions were asked only of households in Wave One of the survey. Households with which we made first contact at waves two to five (quarterly LFS sample) or waves two to four (boost sample), were not asked these questions. For these households this information is not available for Jan-Mar08. Also, because of the risks inherent in modifying the questionnaire at such a fundamental level, and the resources required to do so, it will not be practical to collect this information at future waves.

### **Weighting variable**

The weighting variable is called PWT07.

### **Changes made since the release of the QA dataset.\***

Finally the following changes have been made since the production of the QA dataset:

- For Q3 of the variable **agedfe** 6 cases have been amended from 0 to -8
- For the variables **hiqua18y** and **hiqua8y** bridging variables have been added for Q3.
- Q3's data have been added to **ward03**
- The following geographies have been updated to reflect the latest NSPD: **ualadgb**, **uala**, **uacnty**, **govtor**, **govtof**, **govtof2**.
