The Raw Database

This section of the User Documentation describes the raw database. The raw database contains data 'as it was received' as well as the derived variables calculated within the questionnaire.

The document is in three parts, as outlined below.

Part 1: Raw table definition

This part of the document is about information on sources for the raw data.

Part 2: Raw variable lists

This list allows details of a variable (such as the table in which it is found) to be looked up if the variable name or variable description are known. The following information is contained in the list:

Variable name: the database name of the variable

Variable description: a brief description of the variable

Table name: the SPSS file in which the variable can be found (this will inform you whether the variable type is at household level or person level)

Part 3: Raw variable coding frame

This lists the coding frame for each of the variables in the questionnaires. Household variables are given first followed by variables from the Income questionnaire.

Variable Blocks

Each question is part of a block according to the topic it falls under. For example, questions about gas payments are in the Gas Payment block, which is called QGasPay. Respondents are asked how they pay for gas, whether they receive rebates, how much they paid last time and so on. Users should refer to the Household and Income questionnaires to see exactly which block any given variable belongs to.

Variable Loops

Users need to be aware that for some variables more than one "loop" may exist. This is where the same questions have been asked more than once.

- "rawper" for data pertaining to personal income or expenditure.

For 2010, these SPSS files are as follows:

- 2010 rawhh.sav Household data
- 2010 rawper.sav Person data
- 2010 rawdry.sav Diary data*

***Raw diary information is contained in a separate SPSS file. This information is not publicly available for confidentiality reasons.**

In addition, household and person variables which may be disclosive have been anonymised.
