### Implications of EU-SILC

From April 2012 the FRS will be used to capture the cross-sectional data requirements for the EU Survey of Income and Living Conditions (EU-SILC). Completed FRS interviews will form the sample frame for a follow-up survey, which ONS will use to meet the longitudinal EU-SILC requirements. As a result of this, the following changes have been made to the questionnaire:

#### New questions

- Trailer module on housing conditions:
  - Shortage of space
  - Size of dwelling (in metres)
  - Adequate electrical installations
  - Adequate plumbing/water installations
  - Equipped with heating facilities
  - Comfortably warm in the winter
  - Comfortably cool in the summer
  - Satisfaction with the dwelling
  - Accessibility of grocery services
  - Accessibility of banking services
  - Accessibility of postal services
  - Accessibility of public transport
  - Accessibility of primary health care services
  - Accessibility of compulsory school
  - Immediate risk of changing the dwelling
  - Main reason for move
  - Change of dwelling in last 5 years

- Main reason for change
- Follow-up question referencing the longitudinal EU-SILC element
- Self-reported employment status, for current month and previous 12 months
- Number of dwellings in the building
- Problems with accommodation (damp, not enough daylight, noise, pollution or crime)
- Bath or shower for use by the household
- Inside flushing toilet for use by the household
- Reason for the household not having a colour TV
- Washing machine for use by the household and if not, reason
- Telephone for use by the household and if not, reason
- Computer for use by the household and if not, reason
- Motor vehicle for use by the household and if not, reason
- Value of services per month
- Burden of housing costs
- Country of origin (where other)
- Countries passport held (or entitled to hold)
- Age highest qualification was achieved
- Additional questions to determine highest qualification (degree type, NVQ level etc)
- Qualification currently being studied for
- General health status
- Required a medical examination/treatment but did not receive it, and reason
- Required a dental examination/treatment but did not receive it, and reason
- Burden of loans
- Household could afford to eat meat, chicken or fish (or vegetarian equivalent) every second day
- Household could afford to pay a necessary but unexpected expense
- Household's ability to make ends meet
- Minimum amount of money required to pay usual expenses
- Amount of tax paid on redundancy payments
- Amount of tax paid on training allowances
- Amount received regularly from friends and family each month
- Amount given regularly to friends and family each month
- Value of alimony payments made
- Amount of tax paid on rent received in the last 12 months
- Amount of tax paid on bonuses
- Employment status of odd-jobs
- Number of times household has been behind with bills in the last 12 months
- Main reason for changing job
- Employment contract status for main job
- Age started first regular job
- Number of rooms used only for cooking and food preparation
- Exact year started living at the address
- Reason for not being able to keep the house warm

- Number of hours in school

### Amended questions

- Routing for a number of questions amended to be asked of those aged 16+, in addition to adults (including HiQual and Corign)
- Follow-up question: only those not pre-selected for the EU-SILC longitudinal element to be asked the general follow-up question.
- Contribution to the cost of the motor vehicle: wording changed to be consistent with GLF
- Services: electricity, gas and liquid or solid fuel added
- Number of employees at place of work: additional answer categories
- Highest qualification: revised answer categories
- Debt: rent, mortgage payments, and other payments added
- LikeHr and NoMor replaced by one question: wording changed to be consistent with GLF
- Look: replaced by two questions to separate looking for work and looking for training, to be more consistent with GLF
- YearLive, MonLive and YrLvChk: routing changed to be based on the new question on year started living at the address
- YrLvChk: year reference changed to be 2008 and not updated annually.
- Routing for occupation questions (such as ftwk, ptwk, SOC and SIC) to be changed to include those who are retired

## Non-EU-SILC related changes

### New Questions

- Support (income and non-income) received from the 16-19 Bursary Fund
- Arrangements for making child maintenance payments

### Deleted Questions

- Prescription questions removed (MedPay, MedWho, MedPrPay, MedPrPd, MedNum, MedRep, MedRepNm, Med12m)
- Child maintenance payments covered by a court order (MrCt)

### Amended Questions

- Disability questions: Replaced by the harmonised standard questions
- CBAamt: Additional answer category to capture £0
- Ben5Q: additional interviewer instruction to exclude benefits referenced in previous questions
- ESAType: Additional answer category to capture those receiving both income based and contributory payments
- JSAType: Additional answer category to capture those receiving both income based and contributory payments
- LegDep and Ben1Q: additional interviewer note to be added to reflect planned changes in Child Benefit policy

- OthDed: Additional answer category to capture student loans
- Othded1: Additional answer category to capture student loans
- Deduc: Routing changed to capture amount of student loan
- UDeduc: Routing changed to capture amount of student loan
- Acclnt: Interviewer instruction to check amounts over £10.
- OddJob: Additional interviewer instructions to record the details in the job section if done on a regular basis
- Freeitem: Additional answer category to capture free school fruit and vegetables (and associated follow-up questions)
- GrWage: Additional interviewer note to include overtime, bonuses, commission, tips or other payments
- Followup: wording amended to be in line with DWP legal advice
- Ethnicity: revised wording and answer categories to be consistent with harmonised standards
- Train and NITrain: additional check when New Deal answer categories are chosen
