1 Summary

This booklet describes the main changes which have been made to the 2012/13 FRS questionnaire.

The changes have been made to meet the changing information needs of policy makers for example to reflect the changes in benefit recipient rules. Changes have also been made to improve the survey by acting on suggestions made by interviewers in the last survey year, via the Field Report, telephone and e-mail and also through suggestions made during briefings.

Further to this there have been some major changes to the questionnaire for 2012/13 as the result of the inclusion of questions originally asked on the General Lifestyle Survey (GLF). As this survey has now ceased the some of the questions asked on this survey have been transferred to FRS. These questions are used for the Statistics on Income and Living Conditions (also known as EU-SILC) and by required by European law. Where possible we have identified these questions with the following 'EURO-STAT requirement'.

When at all possible, suggested changes are made and these are acknowledged in the Guide to Changes. Sometimes it is not possible to act on suggested changes, for example if the suggested change will:

- create inconsistencies with other surveys, for example where the change will affect a harmonised question;
- increase the length of the questionnaire;
- conflict with information needs of FRS data users;
- have a negative effect on other parts of the survey.

Thank you to all the interviewers who worked on the 2011/12 FRS. We hope you continue to enjoy working on the survey.
