Welcome

How we treat people with learning disabilities

18. It has been reported 2,300 people suffering from autism and learning disabilities are being locked up in UK hospitals receiving inappropriate treatment. Hospital care

Employment issues

20. At a conference fringe meeting a councillor suggested that people with mental health problems may be unable to work because employers were unwilling to pay them the statutory minimum wage. A peer responded “You make a really good point about the disabled. There is a group where actually, as you say, they’re not worth the full wage.”

It has been suggested that the Government should draw up a Charter of Rights for people with learning disabilities and their families which would include employment.
